3. Reasonable expenses incurred by such displaced person for evidence of title, recording fees and other closing costs incident to the purchase of the replacement dwelling, but not including prepaid expenses.

8. The additional payment authorized by this section shall be made only to such a displaced person who purchases and occupies a replacement dwelling which is decent, safe and sanitary not later than the end of the one-year period beginning on the date on which he received final payment of all costs of the acquired dwelling, or on the date on which he moves from the acquired dwelling, whichever is the later date.

Sec. 3. Emergency

To preserve the public peace, health and safety it is necessary that this act become immediately operative. It is therefore declared to be an emergency measure, to take effect as provided by law.

CHAPTER 173

SENATE BILL 1245

AN ACT

RELATING TO EDUCATION; PRESCRIBING THAT THE ARIZONA BOARD OF REGENTS SHALL MAINTAIN AN ARIZONA STATE UNIVERSITY CAMPUS IN WESTERN MARICOPA COUNTY DESIGNATED AS ARIZONA STATE UNIVERSITY WEST CAMPUS, AND AMENDING SECTION 15-1601, ARIZONA REVISED STATUTES.

Be it enacted by the Legislature of the State of Arizona:
Section 1. Section 15-1601, Arizona Revised Statutes, is amended to read:

15-1601. State universities; location; faculty powers

A. The Arizona board of regents shall maintain state universities at Flagstaff in Coconino county, at Tempe in Maricopa county and at Tucson in Pima county, and the universities are respectively designated Northern Arizona university, Arizona state university and the university of Arizona. THE BOARD SHALL MAINTAIN AN ARIZONA STATE UNIVERSITY CAMPUS IN WESTERN MARICOPA COUNTY DESIGNATED AS ARIZONA STATE UNIVERSITY WEST CAMPUS. The board may establish and maintain other colleges and universities subject to legislative authority.

B. The universities shall have colleges, schools and departments and give courses of study and academic degrees as the board approves. The faculties of the universities shall have and exercise in the government of their respective colleges, schools and departments the powers and authority the board prescribes.
